1. The APPLICANT hereby acknowledges and agrees that:
  - 1.1 Waterford Carriers (from here on referred to as the COMPANY) may carry out a credit check with any licensed Credit Agencies, which will retain a record of that search.
  - 1.2 The existence of this account may be recorded with a Credit Agency, and details of how the account is conducted may be recorded and shared with other lenders for the purposes of assessing further applications for credit by the APPLICANT and members of the APPLICANT'S household, and for occasional debt tracing and fraud prevention.
2. The standard conditions of sale of the COMPANY as stated in this agreement shall form the basis of all transactions between the APPLICANT and the COMPANY. Included in these conditions are the following:

  - 2.3 The APPLICANT shall be liable for all legal fees and disbursements on the Attorney and Client scale, including collection charges, tracing costs, etc., pertaining to the recovery of the recovery of any amount owing to the COMPANY on any overdue account.
